Extract from Will

In the name of God, Amen, 1, James Sharp of Sadsbury Township, County of Chester and State of Pennsylvania, yeoman, being sick and weak in body but sound mind and memory and calling to mind the uncertainity of human life do make this my Last Will and Testament.

First, I commit my Soul into the hands of Almighty God and my Body to the Earth to be decently buried at the discretion of my Executors in shure and certain hopes of the Resurrection to Eternal Life through our Lord Jesus Christ, and after my just debts and funeral expenses are paid and discharged the residue of my worldly Estate, I give and bequeath as follows:

viz. Imprimis: I give and bequeath to my loving son John Sharp the sum of one Shilling Sterling to hold to him my said son his heirs and assigns forever.

Item: I give and bequeath to my loving son James Sharp the just sum of one Shilling Sterling to hold to him my said son his heirs and assigns forever.

It is my will that the above legacies to paid six months next after my decease.

Item: I give and bequeath to my beloved Grandson James Sharp, son of my son John Sharp and Ann Sharp, his wife, Five Pounds lawful money of this State to hold to him my said Grandson his heirs and assigns forever the same to be paid him when he shall arrive at the age of Twenty-one years.

Item: I give and Bequeath to my beloved Grand Daughter Margaret Sharp Daughter of the said John Sharp and Ann, his wile, the sum of Five Pounds lawful money aforesaid to hold to her my said Grand daughter her heirs and assigns forever, the same to be paid to her when she arrives at the age of Eighteen years.

Item: In like manner I give and bequeath to Each and Every Grand Child of mine that shall be living at the time of my Decease the like sum of five pounds lawful money of this state to be paid to the male children at the age of twenty one years and to the females at the age of eighteen to hold to them and every one of them their heirs and assigns forever.

Item: I give and Bequeath to my loving wife Mary Sharp that my executors do pay her yearly and every year out of the income of my estate the just and full sum of Ten Pounds lawful money during the time she remains Widow Sharp and when she changes her condition by marriage that they pay her one Hundred Pounds lawful money of this State to her her heirs, executors, administrators or assigns forever and that she my said wife have the pricilege of a room in the house in which I at present dwell with fire wood and pasture for a horse and cow during the time she remains my widow as aforesaid and fulther I give and

Bequeath unto my said wife one gelding horse and saddle and one Feather Bed and furniture for the same to her heirs and assigns for-

Item: I give and bequeath all the remainder or my Estate both real and personal as follows. (viz):

Item: I give and Bequeath to my beloved Son Joseph Snarp all that part or parcel of my real Estate called the Homsted whereon I now awell, together with that Tract of land adjoining James Williams Thomas Climson and others to have and to hold to him the said Joseph Sharp and the heirs of his Body Lawful begotten or to be begotten forever with all and singular the Appertenances thereunto belonging.

Item; I give and Bequeath to my said son Joseph a black walnut Desk and one set of pleat coat Buttons to him his heirs lawful Issue as a-foresaid forever.

Item: I give and Bequeath to my beloved Daughter Sarah Sharp all that part or parcel of my real Estate joyning the Sone meeting House whereupon Andrew Willson now dwells and a Small Tract of wood land near the frame Meeting House with all Singular the Appertenances thereunto belonging to have and to hold to my said Daughter Sarah the said part or parcel of my Estate to her and the heirs begotten or to be begotten forever.

Item: I give and Bequeath unto my Said Daughter Sarah the just sum of one Hundred pounds lawful money of this State in Good Sufficient Bonds to be paid when She arrives at the age of Eighteen to have and to hold to her and the lawful Heirs of her Body forever.

Item: It is my will that all the Kemainder of my Personal Estate and Negroes to be sold at any convenient time after my decease at the Discretion of my Executors and the money together with the Bonds and Book Debts if any be put out to Interest and it is my will that said Interest and the Rents of the before bequeathed tracts of land be approprieted to the use of mentaining and edicating my said son and Daughter Joseph and Sarah and what remains of principal and interest of my personal Estate to be equally Divided between my son and Daughter Joseph and Sarah Sharp to hold to them and their lawful Issue for ever as they shall arrive at lawful age and in case of my said son Joseph should Die without the lawful issue above mentioned the above Estate as Bequeathed to my said son Joseph I give and Bequeath to my said Daughter Sarah to hold to her and the lawful Heirs of her body begotten or to be begotten forever so it is my mind that whatsoever is willed to the said Joseph and Sarah Sharp the surviving Heir shall have the whole but it both my said Children Joseph and Sarah Sharp should die without the above mentioned lawful issue then it is my mind and will that the said Rale and Kemainder of my personal Estate be Equally Divided among my Grand Children that then shall then be alive to hold to them their heirs forever. Except one Hundred pounds to be given to my loving wife Mary Sharp to her and her heirs forever.

I will that the Steepings which I subscribed to the Reverend William Foster yearly and every year be paid to him out of the Income of my Estate untill my said children Joseph and Sarah Sharp shall come or age.

Lastly I nominate Constitute and Ap oint my Trusty Friends and Kelations the Reverend William Foster and John Sharp of Sadsbury Township William Clingan Esq. of West Caln and William Heslip of West fallow-field Township Chester County State of Pennsylvania, Executors of

this my last will and Testament hereby Kevoking and making void all former Wills and Testaments by me made <u>Requisting</u> that my Executors Shall be <u>perticularly cearful</u> that such tenements as are or shall be placed on my lands as aforsaid left shall be Oblidged not to destroy the Timber.

in witness to the whole I have hereunto set my Hand and Seal this 14th Day of February, 1777.

I. JOHN SHARP, Sr.; b. 1727; d. 18 Oct 1816; m. Ann Boyd, b. 1734; d. 15 Mar 1810. Captain James M. Sharp, a grandson, wrote in his recollections (1894) information about his grandparents that he obtained from his father, John Sharp, Jr. who settled in Sevier County about 1806 and died there in 1844. Captain Sharp said that John Sharp, Sr. was born in the "County of Meath or Myth, Ireland He is of Scotch-Irish parents whose given names I never knew. After arriving at manhood he came to Pennsylvania, Lancaster County, and engaged in teaching a "Fencing School" for seven years in succession. At the close of each session of school, he would collect his pay," and buy Flax seed "which he carried over to Ireland each Fall." He then married Miss Ann Boyd of his native country and afterwards came to the United States and settled in Lancaster County, Pennsylvania on a creek called Canegogig where he became the owner of three large and valuable farms." He lived here several years before the Revolution and had a large family by that time. He lived within "fifteen miles of the Battle of Brandywine," and volunteered with "two Irish servants" to fight in that Battle(11 Sep 1777). Later he sold his lands in Pennsylvania to a man by the name of "Coater," and was paid in Continental money. With his first installment he was able to buy a "good farm in Augusta County, Virginia, tenn miles northwest of Staunton and within two miles of Middlebrook near the North Mountains and on the North Hiver." By the time his other payments were due the Continental money was worthless, and he was so "improvershed" that he was unable to do much to aid his large family. Both died in Virginia. The above dates were obtained from the THOMAS SHARP Bible, now (1949) in the possession of Reuben Sharp, Loudon, Tennessee. The dates were obtained from the following statement: "My grandfather in October 18,1816 died- My grandnnete died March th 15 1810- age 76- father 89." It is believed that this was written by Alexander Sharp, father of Thomas Sharp, and referred to Alexander's grandfather and grandmother, John Sharp, Sr. and Ann Boyd Sharp. Also the date of John Sharp Sr. Will was July 2, 1816, and it was proven in court, 27 Jan 1817. See Chalkey, Augusta Abstracts V. III, page 227. (Written note: Will of James Sharp, Chester Co., Pa., made 1777, probated 1782. He named son, John Sharp and wife Ann. Believed to be father of John Sharp Sr.)

Captain Sharp stated in his recollections that ROBERT SHARP moved to Williamson County, Tennessee, and later lived and died near Murfreesboro, Tennessee. In 1925, Mrs. H.C. Jones, New MArket, Alabama; corresponded with Mrs. Sterling Fort, Clarksville, Tennessee; the latter gave her the above information without dates and no dates are available at present. Mrs. Fort also stated the "Robert Sharp and Mary Porter were born in Augusta County, Virginia, were married there, and came to Tennessee between the years 1808-12, and settled in Williamson County." Mrs. Fort also quoted from a William H. Sharp, 2115 Grantland Ave., Nashville. Tennessee, the following: "My grandfather, ROBERT SHARP, left some point in Georgia 4 May 1794 and settled in Williamson County, Tennessee. I got this from an old almanac used as a diary, I suppose, by a Dr. James Boyd Sharp, and this is all the family history I know." The writer has learned that Mrs. Fort is dead and has been unable to contact a descendant who might have "a more complete record of the family. However, Robert Sharp was still living in 1828, and attended the personal property sale of his brother Joseph's estate in Augusta County, Virginia. It seems that he inherited considerable property from Joseph, but the latter's will is not available.

The dates for this family were obtained from the JOHN SHARP, JR. BIBLE (Mathew Carey, Philadelphia, 1802). The Bible was purchased by John Sharp Jr. in 1803, and is now in the possession of Miss Mary Sharp, his great grand dauhgter, Sevierville, Tennessee. Of John Sharp Jr., his father, Captain James Sharp stated that he came to Virginia with his family, and that he remembered his mother's great "anziety and distress" for her husband during the battle of Brandywine. He remained in Virginia for anly a few years and then decided to go to Savannah, Georgia to study medicine under his older brother James. He stopped in Blount County, Tennessee, to visit his sister, Margaret (Sharp) Weir and her husband, James Weir; while here the Cherokee Indians attacked the frontier settlemts and murdered the Kirk family on Nine Mile Creek. Later a general Cherokee attack resulted in the burning of the Weir home, and he decided to return to his father's in Virginia since his route to Georgia passed through the Cherokee country. However, he only reached Greenville, Tennessee, and there he joined the army being raised by General John Sevier. He served in this force for two years, part of the time as a spy under Captain James Cunningham, and was present at the "celebrated defeat at the mouth of Citico Creek." He was also present at the battle of Lookout Mountain near the present Chattanooge when the Indians defeated the white forces under General Martin.

After peace was made he made a crp on his farm near Maryville, Tennessee, and with the money from his crop he bought horses from the Indians and drove them to Virginia. "On getting to his father's, none of the family knew him as he was dressed in the Indian costume of buckskin from head to foot and by this time had grown a beard." After this he engaged in the fur trade, deliverong his furs in wagons to Philadelphia and drove large herds of cattle from "Virginia to Maryland and Pennsylvania." He also attended the Negro slaes in the Richmond section and when "he saw a chance to make money would buy them and bring them to Western Virginia and sell them. " He engaged in such trading activities for eleven years, and Captain Sharp said that his father told him that "he had traveled 31 times from Tennessee to Staunton, Virginia, and seven from here to Philadelphia, all on horseback." After his first marriage in 1796, he settled on his farm near Maryville, and lived here until 1806 when he moved to his large farm near Trundle's X Roads in Sevier County, Tennessee, where he died in 1844.

Dates for this family wereobtaines from the Thomas Sharp Bible and the Clark Bible, now in the possession of John Clark, Maryville, Tennessee; also from markers in Clark Grove Cemetery near Maryville, Tennessee. ROBERT SHARP, husband of Letitia, presented quite a problem. Nothing is known about his ancestry. In 1927, the late Will Parham, Blount County genealogist, interviewed the late Robert Sharp, Rockford, Tennessee, and heard the old family tradition that ROBERT SHARP was "killed by Indians on Pistol Creek, near Maryville and is buried on the Will Brakebill farm, 7 miles northeast of here." Another version of the same story was that he was killed in 1792 "by an Indian striking him on the head with a tomahawk as he was crossing Pistol Creek with a hay fork on his shoulder, on his way to gather up hay." (See Parham Papers, McClung Room, Lawson-McGhee Library, Knoxville, Tennessee.) That Robert Sharp was actually killed by the Indians is proven by a contemporary account in the Knoxville Gazette of October 6, 1792. This account follows:

"On the 3rd instant Black's Block House, on the head of Crooked Creek(a branch of Little River) at which there was a serjeant's command of Captain Crawford;s company, was attacked, by surprise about an hour and a half in the night, by a party of Indians commanded by a Cherokee of Will's Town, called the Tail, a brother of the Bench and Talohtkfke, consisting of three other Cherokees and five Creek.

James Paul was killed in the house, and George Morse and Robert Sharp at a fire on the outside, and John Shankland wounded, three horses were killed and seven taken off."

In August, 1793, the widow, Letitia, settled his estate in the Knox County Court of Pleas and Common Sessions as shown by the following entry in Estate Book, I, page 10: "Amt of the sales of the estate of Robert Sharp deceased was returned to court by Laticia Sharp administrator and admitted to be recorded. Amounting to two hundred and Sixty-four Dollars - Jan. 21st 1793. Laticia Sharp Adm." Letitia Sharp married John Clark, Revolutionary veteran, in 1801, but no children were born to this union; however, her daughter, Nancy Sharp, married James Clark son of John by a previous marriage in 1808, and Letitia seems to have spent her latter days in the home of James and Nancy. Robert Sharp, before settling in Blount County, owned land in Rockbridge County, Vir-

ginia, and may have lived there with his family. This is shown by powers of attorney given to Alexander Sharp by his brothers, Edward and James Boyd, in 1813 and 1814, for the purpose of collecting money due their father from one Thomas Maclin who bought the land from Robert Sharp but did not pay for it and received no deed. The land was located five miles from Lexington, and a man named "Elliot" lived on it in 1814. It is not known whether Alexander made any attempt to collect for this land or not. The court records of Rockbridge County might reveal a lawsuit which would tell more about Robert Sharp. (See Blount County Deed Abstracts, Parham Papers, McClung Room, Lawson-Mc Ghee Library, Knoxville, Tennessee.)

The date of the son, Addison's birth, was not solved. The Clark Bible simply states: "Addison Sharp departed this life May 27, 1832, aged 36 yrs." This would place his birth in the year 1796, four years after Robert Sharp was killed by the Indians. Mr. Parham decided that writer of this made a mistake of ten years and thathis age was 46 at the time of his death; therefore his birth would have been in the year 1786. however, the Blount County consus record of 1830 places his birth between the years 1790-1800, so apparently Mr. Parham; s theory was incorrect.
